ORDINANCE NO. 2020-01

AN ORDINANCE OF THE CITY OF SOUTH PASADENA, FLORIDA, AMENDING ORDINANCE No. 2019-08 BY REDUCING THE NUMBER OF WORDS IN THE BALLOT TITLE LANGUAGE TO FIFTEEN WORDS; PROVIDING FOR SEVERABILITY, PROVIDING AN EFFECTIVE DATE.

WHEREAS, pursuant to the provisions of the City of South Pasadena City Charter ("City Charter") a Charter Review Committee was impaneled and conducted a review of the City Charter; and

WHEREAS, in Ordinance No. 2019-08 ("Ordinance") the City Commission approved proposed amendments to the City Charter and submitted them appear on the ballot for a vote to the citizens of the City of South Pasadena;

WHEREAS, the Ordinance provided for ballot title language as well as ballot question language; and

WHEREAS, per Florida Statutes Section 101.161(1), the ballot title cannot be longer than fifteen (15) words; and

WHEREAS, the ballot title languages set forth herein revises the ballot title language in Ordinance No. 2019-08 to be no longer than fifteen (15) words; and

WHEREAS, the reduction in the ballot title language does not substantively revise adopted the ballot title language, but allows the ballot title language to procedurally comply with Florida Statutes.

NOW, THEREFORE, BE IT ORDAINED by the City Commission of the City of South Pasadena, Florida:

SECTION 1. Section 2 of the Ordinance shall be revised by deleting the strike-through language as follows:

~~CHARTER AMENDMENT~~ REVISING THE TERM OF CITY COMMISSIONS FROM THREE (3) YEAR TO FOUR (4) YEAR TERMS.

SECTION 2. Section 4 of the Ordinance shall be revised by deleting the strike-through language as follows:

~~CHARTER AMENDMENT PROVIDING FOR SEPARATE TERM LIMITS FOR THE MAYOR AND THE COMMISSIONERS; AND ALLOWING A COMMISSIONERS TO BE ELIGIBLE AS A CANDIDATE FOR MAYOR AFTER SERVING ALL ALLOWABLE TERMS AS A COMMISSIONER.~~

SECTION 3. Section 6 of the Ordinance shall be revised by deleting the strike-through language and adding the underlined language as follows:

~~CHARTER AMENDMENT PROVIDING FOR THIRTY (30) CALENDAR DAYS FOR THE COMMISSION TO APPOINT AN ELIGIBLE PERSON TO FILL A VACANCY ON THE COMMISSION AND PROVIDING THAT THE APPOINTMENT CANNOT BE LONGER THAN SPECIFIED EITHER THE NEXT GENERAL ELECTION IN WHICH THE UNEXPIRED TERM CAN BE FILLED OR MORE THAN FIFTEEN (15) MONTHS.~~

SECTION 4. Section 8 of the Ordinance shall be revised by deleting the strike-through language as follows:

~~CHARTER AMENDMENT PROVIDING THAT THE MAYOR SHALL APPOINT THE VICE MAYOR DURING A REGULAR COMMISSION MEETING. AFTER EACH ANNUAL REGULAR ELECTION INSTEAD OF DURING A SPECIAL COMMISSION MEETING.~~

SECTION 5. Section 10 of the Ordinance shall be revised by deleting the strike-through language as follows:

~~CHARTER AMENDMENT PROVIDING THAT THE MAYOR AND COMMISSIONERS PER RESOLUTION ARE ELIGIBLE TO RECEIVE THE SAME COST OF LIVING INCREASES CONSISTENT WITH OTHER CITY EMPLOYEES.~~

SECTION 6. Section 12 of the Ordinance shall be revised by deleting the strike-through language as follows:

~~CHARTER AMENDMENTS PROVIDING THAT CITY ELECTIONS WILL BE HELD ON THE SECOND TUESDAY IN MARCH EACH YEAR, AS NEEDED.~~

SECTION 7. Section 14 of the Ordinance shall be revised by deleting the strike-through language as follows:

~~CHARTER AMENDMENT CREATING THE NEW POSITION IN CITY ADMINISTRATION OF A CITY ADMINISTRATOR, AS NEEDED, TO BE THE HEAD ADMINISTRATIVE OFFICER OF THE CITY AND PROVIDING FOR THE DUTIES. OF THE CITY ADMINISTRATOR.~~

SECTION 8. Section 16 of the Ordinance shall be revised by deleting the strike-through language as follows:

~~CHARTER AMENDMENT REVISING EXISTING CHARTER LANGUAGE TO CLEARLY DESCRIBE THE PROCESS FOR THE ADOPTION OF ORDINANCES BY CITIZEN INITIATIVE.~~

SECTION 9. Section 18 of the Ordinance shall be revised by deleting the strike-through language as follows:

~~CHARTER AMENDMENT REVISING EXISTING CHARTER LANGUAGE TO CLEARLY DESCRIBE THE PROCESS FOR THE TIME FRAME FOR CHARTER REVIEW AND CREATION OF CHARTER REVIEW COMMITTEE MEMBERSHIP.~~

SECTION 10. Section 20 of the Ordinance shall be revised by deleting the strike-through language as follows:

~~CHARTER AMENDMENT REVISING THE CHARTER TO REQUIRE THAT THE CITY COMMISSION PLACE AN ITEM WITH THE RECOMMENDATIONS OF THE CHARTER REVIEW COMMITTEE ON THE FIRST AVAILABLE AGENDA FOLLOWING THE SUBMISSION OF THE COMMITTEE REPORT INSTEAD OF AN ORDINANCE.~~

SECTION 11. This ordinance shall become effective immediately upon final passage, nunc pro tunc to January 2, 2020.
