Dear South Pasadena City Commission -

My name is Dan Palmer, and I am affiliated with Amerisong. Amerisong is a volunteer, citizen-based community choir organization that performs in honor of and for American armed forces veterans and active-duty personnel. (At veterans' homes, funerals, for returning service men and women, etc.) The Tampa Bay area has been selected as the pilot program for this national organization, with myself as the conductor. I am a resident of South Pasadena, am a life-long professional musician, and have five years experience and training as a choir conductor.

We are looking for a rehearsal facility that has a piano available, and your Cultural Arts Center seems to be a perfect match. We would have a place to rehearse, and music would be brought back to our community. We are hoping to begin rehearsals in September.

In the meantime, I will be searching for an accompanist and gathering prospective members. The choir will be open to all citizens, regardless of age, race, or experience. The repertoire will consist of military hymns, patriotic music, and selected traditional sacred music. Repertoire is being selected, arranged, and coordinated by prominent Armed Forces musicians and conductors.

That is the first subject I hope to discuss with you.

Secondly, I am Chief Videographer and Producer for a video production business called Docucrew, LLC. My partner, Melisa Maxey, was named St. Petersburg College's "Social Entrepreneur of the Year 2014" for Docucrew's work on behalf of local non-profit agencies. In that pursuit, we occasionally need a space to film interviews. The Cultural Arts Library space would work quite well for the purpose, and we would like to discuss such a partnership with you at the meeting.
